### **Hunter Education (Online + Field Course)**

Hello All,

Welcome, and thank you for training with the National Protective Services Institute (NPSI). We are looking forward to meeting and training with you. Here is information to make your training more enjoyable.

Texas Hunter Education certification is offered by Texas Parks and Wildlife Division (TPWD) certified instructors. Candidates must complete the online coursework PRIOR to attending class. The following information will explain how this is accomplished.

**Part 1- Online coursework** (Ethical hunters will do their own online coursework.)

#### **Part 2- Field Course**

The Field Course includes: a presentation of ethical and responsible hunting, participation in a hunting skills trail, a live firing exercise, review of regulations and a final exam (score at least 80% to pass). The Field Course is completed in one day and includes a minimum of four (4) hours of instruction and a live fire exercise. Parent/Guardian shall accompany the child(ren). **You must pre-register on for this course** to reserve a seat.

#### **When you arrive at the Field Course site:**

- Turn in (without these items, you will not participate)
  1. NPSI Registration form
  2. NPSI liability waiver
  3. Shooting range liability waiver
  4. Printed results from Part 1 homework (Quiz Results, Voucher or Certificate)
  5. \$15 (cash, if not paid online)
- Demonstrate appropriate **KNOWLEDGE, SKILLS** and **ATTITUDE** while completing the Field Course subjects: ethics and responsible hunting, regulations, hunter skills trail, and live firing exercise

- (Honorably discharged or active military are exempt from live fire exercises only. Present your DD Form 214 or ID card.)
- Take the written exam and score at least 80% correct to pass
- Upon successful completion of Parts 1 and 2 of the Hunter Education course, you will receive a temporary Texas Hunter Education student card. You may legally hunt with a valid Texas hunting license and your temporary student certification card on your person. Your permanent Texas Hunter Education certification card will be mailed within a few weeks

**Note.** Texas law requires hunters to carry their Hunter Education card on their person while hunting.

With all that behind us, we are training at the National Shooting Complex (NSC) [5931 Roft Road](#) San Antonio, Texas 78253. The NSC is five square miles. See attached map to the classroom building.

We begin the Hunter Ed session at **1400/2PM**. We will end as soon as we are done; about 1800/6PM. Large classes run longer.

Dress code is comfortable and clean. You will be walking in the grass and trees. **No open toed shoes**. You may bring lunch, drinks, and snacks. Vending services are not normally available.

Special equipment and ammunition you may bring to use your own...

- Ear Protection
- Eye Protection
- Baseball type hat recommended
- Shotgun of your choice (If you want to bring your own.)
- Ammunition; no shot larger than 7 ½ is allowed. HE students shoot 3-5 shots.

## **Student Waiver, Safety Rules, and Assumption of Risk Form**

### **1. WEARING/USE OF WEAPONS**

Knives, Batons, Spray, Stun/Electric devices may be retained at the discretion of the instructor. Under no circumstances shall live ammunition be in the training environment. Firearms and ammunition shall be unloaded or secured during training except when authorized. **FIREARMS SHOULD NOT BE LEFT IN YOUR VEHICLE.**

**EXCEPTION:** If an operational firearm is used in training, it shall be **UNLOADED** and verified. All firearms will be examined by two people (the instructor, owner, or his/her partner) to make certain the firearm is **UNLOADED**. Under no circumstances will any participant have live ammunition on his/her person when an operational firearm is used during training.

### **2. WEARING OF JEWELRY, ETC.**

All jewelry with sharp edges, pins, or raised surfaces or jewelry which encircles the neck should not be worn during a class which involves hand-on training. Participants should consider removing rings since swelling of the fingers could occur if the hand were to be injured, perhaps requiring the ring to be cut off.

### **3. NO HORSEPLAY IS TOLERATED.**

Any participant who displays a disregard for **SAFETY** to anyone in class will be asked to leave the class.

Practice only the technique currently being taught. **DO NOT PRACTICE UNAUTHORIZED TECHNIQUES.**

### **4. NO TRAINING HAZARDS.**

**KEEP BATONS AND ALL OTHER TRAINING EQUIPMENT (i.e. UTB, etc.) UP OFF THE FLOOR/GROUND (COMPLETELY OUT OF THE WAY) WHEN NOT IN USE.** Keep equipment off floor and away from students; avoid walls, countertops, and other hazards; stay on mats when performing training techniques.

### **5. PAT OUT/TAP OUT RULE.**

If a **RESTRAINT** technique is applied to the point of pain compliance or beyond, immediately **"PAT"** twice and rather sharply somewhere on your body with your free hand (or feet). Upon hearing/feeling/seeing the **"PAT"** your partner who is applying the technique will immediately release the pressure of the technique to reduce pain compliance. The technique will be immediately and totally released on instructions from your instructor or a safety monitor says **"RELEASE"**, **"STOP OR WORDS SIMILAR TO THEM."**

### **6. PRACTICE TECHNIQUES SLOWLY AT FIRST.**

Gain control and correctness slowly before practicing for speed. Proceed at the pace directed by your instructor.

### **7. ADVISE YOUR INSTRUCTOR AND YOUR PARTNER OF ANY INJURY THAT MAY LIMIT YOUR PARTICIPATION.**

Any injury or condition that could be further injured or aggravated should be brought to the immediate attention of your instructor or your partner prior to participating in any hands-on training.

A **RED WRIST BAND** or other colored wrist band worn by any training participant is the sign to warn of injury **USE CAUTION WITH A PARTNER WHO IS WEARING A COLORED WRIST BAND.** Contact your instructor **NOW** if you need a **RED WRIST BAND.**

Certification through **TRAINING**, not attending!

**8. ADVISE YOUR INSTRUCTOR IMMEDIATELY OF ANY INJURY THAT OCCURS DURING TRAINING.**

All blood shall be immediately reported, controlled and cleaned. **FIRST AID EQUIPMENT IS AVAILABLE. EMERGENCY MEDICAL SERVICES CAN BE SUMMONED, IF NECESSARY. Air Life service is requested for any gunshot wound to the torso or head.**

**9.** All participants and instructors should attempt to maintain as safe a training environment as is reasonably and practically possible.

No instructor can watch all participants at all times. Therefore, each participant is responsible to conduct himself/herself in a safe manner, to abide strictly by these safety rules, and to comply with all instructions given by your instructor or safety monitors.

**SAFETY IS YOUR RESPONSIBILITY AT ALL TIMES! If anyone says to “STOP”, “CEASE FIRE”, etc., DO SO IMMEDIATELY.**

I, \_\_\_\_\_, have agreed to participate in training provided by the National Protective Services Institute or their affiliates/contractors, herein called NPSI. I understand that training activities could be potentially hazardous and may involve strenuous physical activity and the possibility of serious injury or death exists. I warrant that I am in good physical condition to the best of my knowledge. I voluntarily make and grant this Waiver and Assumption of Risk in favor of NPSI, principles and officers, and any instructors/trainers for classes conducted or sponsored by previously named organizations, or property owners for property on which property is used for authorized training, any instructors/trainers for classes conducted or sponsored by previously named organizations, or property owners for property on which property is used for authorized training under the supervision of said organizations, or any student engaged in official training or activities of said organizations while under the supervision of an official from said organizations as partial consideration), in addition to monies paid to said organizations for the opportunity to use the facilities, equipment, materials and/or other assets of said organizations; and or to receive assistance, training, guidance, tutelage, and/or instruction from the personnel of said organizations; and/or to engage in activities, events, sports, festivities, and/or gatherings sponsored by said organizations; I do hereby waive and releases and all claims whether in contract or of personal injury, bodily injury, property damages, damages, losses, and/or death that may arise from my aforementioned use or receipt, as I understand and recognize that there are certain risks, dangers, and perils connected with such use and/or receipt, which I hereby acknowledge have been fully explained to me and which I fully understand, and which I fully nevertheless accept, assume and undertake after inquiry and investigation of extent, duration, and completeness wholly satisfactory and acceptable to me. I further agree to use my best judgment in undertaking these activities, use, and/or receipt and to faithfully adhere to all safety instructions and recommendations, whether oral or written. This form shall also serve as a medical release to allow such actors as mentioned above to take me for any such emergency medical treatment as required. I understand that the risks associated with this law enforcement and security training range from minor injuries to serious bodily injury and even death, including, but not limited to, pulled muscles, bruises, sprains, broken bones, lacerations, and gunshot wounds. I hereby certify that I am a competent adult assuming these risks of my own free will, being under no compulsion or duress who will be participating in these activities or using this equipment. This Waiver and Assumption of Risk is effective immediately and remains in effect as long as I am participating in these activities.

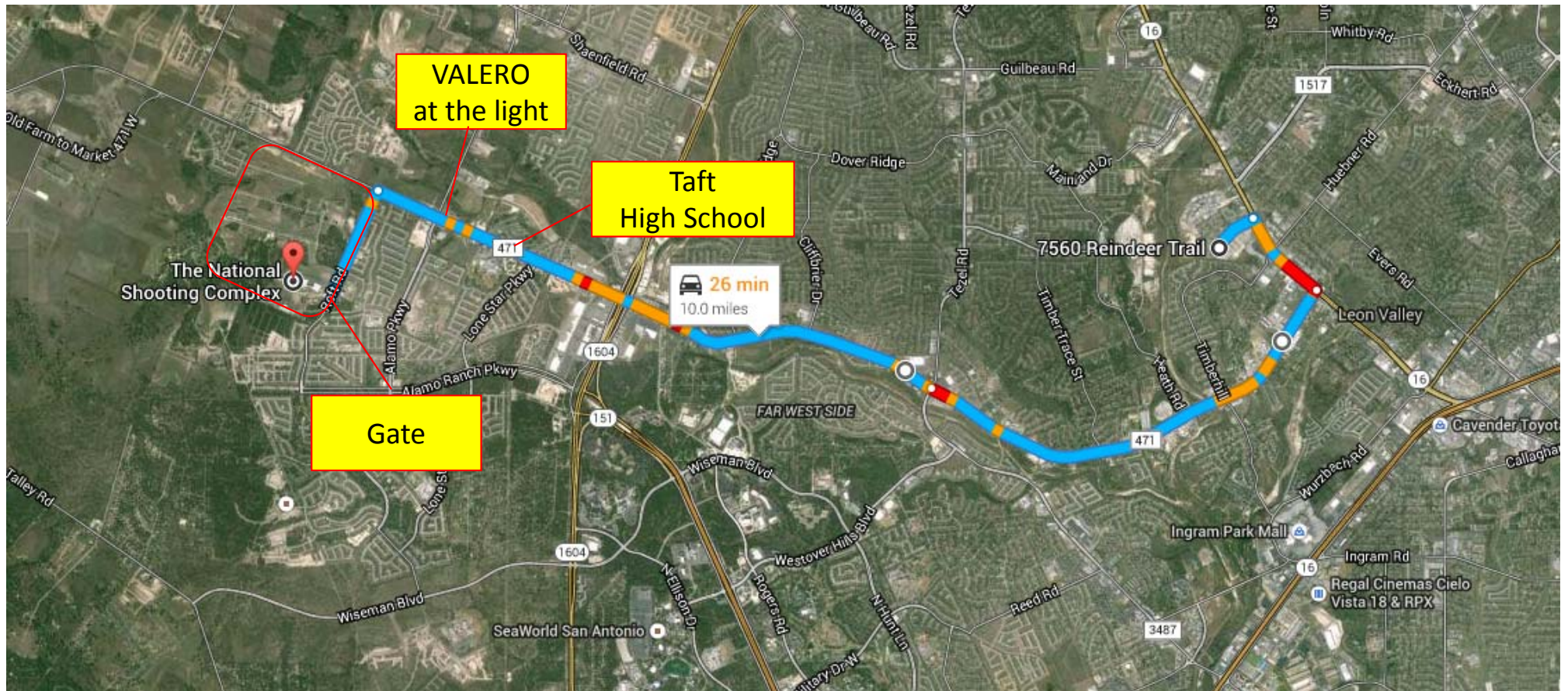

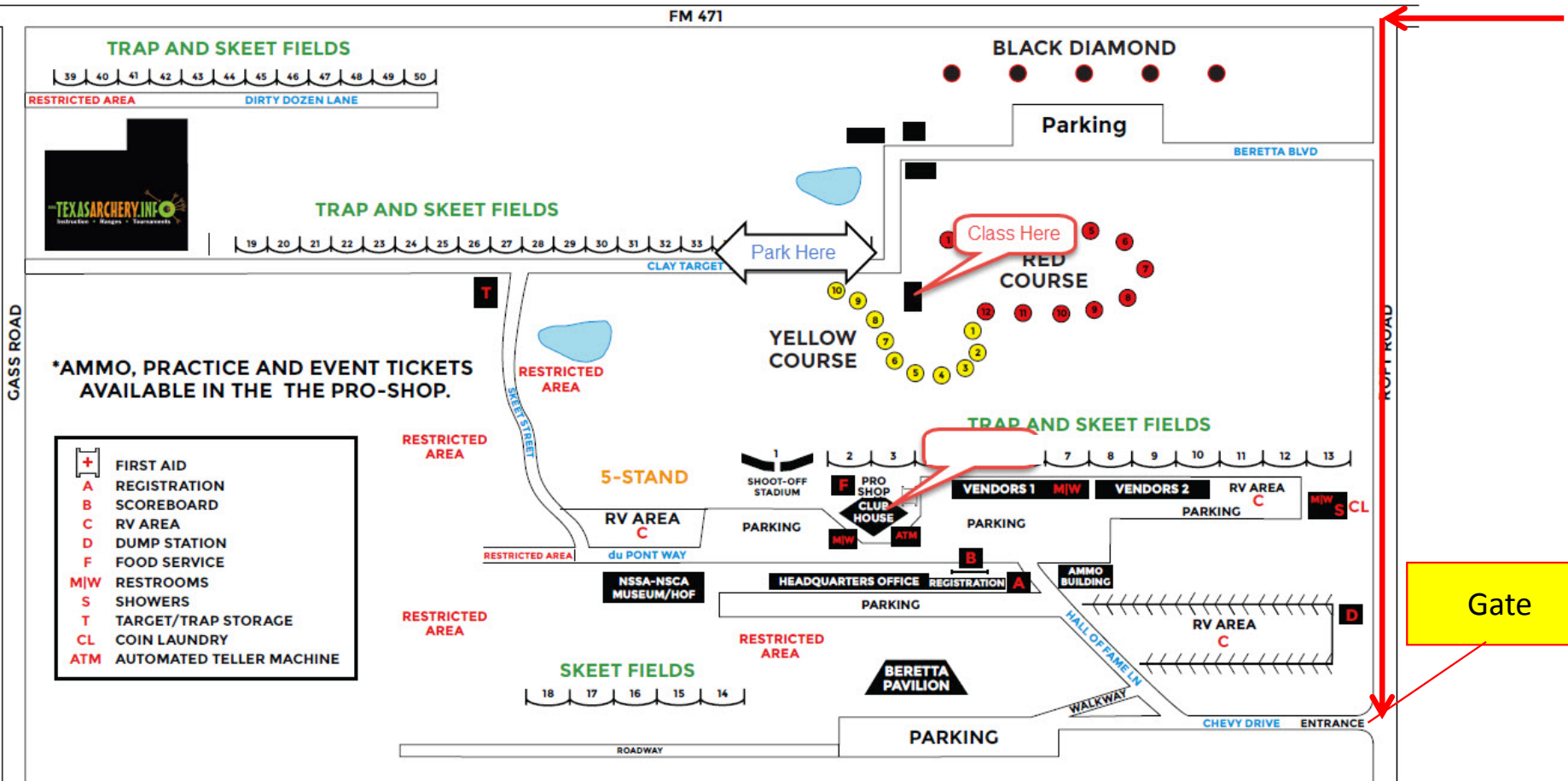

I agree to read and abide by all the NSC Rules Policies and Operating Guidelines, and also I agree to assume any and all risks associated to and with the use of the facilities, including but not limited to: participation in NSC sponsored events, and the use and discharge of firearms, accidental discharge of firearms, and loss of personal property through misplacement, loss or theft while at NSC.

I, and on behalf of my heirs, agents, assigns, beneficiaries, executors and administrators, for the consideration of being allowed to enter and use the facilities and services of NSC, and to observe the shooting competitions, and for other valuable considerations, do hereby absolutely and unequivocally agree to release, save and hold harmless NSC, the Officers and Directors and Members of NSC, its sponsors, agents, employees, instructors, assigns and successors in interest from any claim, demand or liability (whether claimed by myself or another person or entity) which may arise out of any loss, damage, injury or death which I may sustain, as well as any theft, unexplained disappearance or damage which may befall my property accompanying me (whether while en route to, during participation in or during observation of the event(s), and while en route from the event, or while on the NSC premises) where any of the match events occur, with the above use of facilities and services.

## Open Public Shooting

### Rules & Regulations

- All participants and guest must sign a Liability Waiver
- All first time attendees must watch safety video
- All participants must check in at the Pro Shop prior to shooting
- Any participants under 16 yrs of age must have adult supervision at all times while on shooting ranges
- At no time are participants allowed to load, adjust, or repair trap machines-management should be notified of any problems by contacting the range official or by calling the Pro Shop at 210-688-2542
- At no time are participants allowed to enter a skeet or trap house
- At no time are participants allowed down range of any shooting stations
- Eye and ear protection is mandatory for all shooters, spectators, pullers, and trappers on the range
- Treat every gun as if it were loaded / never point your gun at anyone
- All guns are to be unloaded with actions open when you are not on the shooting station
- Keep ammunition of different gauges in separate bags
- Load gun only when on shooting station-load appropriated number of shells for targets to be shot-maximum two (2) shells
- No shells with shot larger than 7-1/2 are allowed
- No games or horse play allowed ie Buddy Shooting, Back-up, Annie Oakley, etc.
- No alcohol is allowed on shooting ranges by participants or spectators
- No shooting allowed following the consumption of alcohol
- No shooting allowed while under the influence of any drugs or prescription medications that affect judgment and conduct to a degree that participant is unsafe
- Hulls that hit the ground become the property of the National Shooting Complex
- National Shooting Complex is not responsible for accidents, lost or stolen property
